

PUBLIC NOTICE FOR EXPRESSION OF INTEREST TO PARTICIPATE IN THE EVALUATION COMMITTEES APPOINTED BY FONDAZIONE BRUNO KESSLER FOR THE SELECTION OF PERSONNEL IN THE CONTEXT OF THE NATIONAL RECOVERY AND RESILIENCE PLAN

Fondazione Bruno Kessler¹, a substantially public entity with legal personality under private law that carries out research and innovation activities, participates in the implementation of the National Recovery and Resilience Plan (PNRR) and related projects.

In the above context, Fondazione Bruno Kessler's selection, recruitment and work relationship management procedures, even if legally falling within the scope of common law, have been made the object of an accurate internal compliance verification with the intention of ensuring adherence to the principles and general obligations relating to the EU and national provisions on PNRR (See Head of the Human Resources Service Resolution No. 13 of 2022)².

It is with this in mind that - in accordance with the principles of transparency, traceability and accountability - this notice is addressed to all those who wish to express their interest in participating, as a member of the Evaluation Committees that will be specifically appointed, in the selection processes related to the positions to be filled for the PNRR projects in which the Foundation is involved.

Eligible candidates include individuals who meet the high and recognized scientific or managerial skills requirements in at least one of the following areas: Cybersecurity, Digital Society, Digital Industry, Digital Health and Wellbeing, Health Emergencies, Sustainable Energy, Sensors and Devices, Theoretical Studies in Nuclear Physics and related areas, Evaluative Research on Public Policy, Religious Studies, Italian-German Historical Studies.

Expressions of interest should be sent to the PEC address risorseumane@pec.fbk.eu (also from ordinary e-mail address), and include an updated CV as an attachment.

For the purposes of the appointment, the high and recognized scientific or managerial skills requirements related to the expressions of interest received will be evaluated, based on the relating CVs, by the Director(s) of the Research and Study Center(s) from the areas listed above and by the Head of the Foundation's Research Assessment Unit.

The appointment as external expert member is finalized with the acceptance by the applicant who, by accepting the appointment, undertakes to comply with the provisions set forth by Fondazione Bruno Kessler regarding personnel selection and PNRR; in this sense, reference is made again to Head of the Human Resources Service Resolution no. 13 of 2022, as well as the provisions of the Foundation's Code of Conduct³.
