**DECLARATION IN LIEU OF AFFIDAVIT
ON THE NON-EXISTENCE OF REASONS FOR IMPOSSIBILITY TO APPOINT AND INCOMPATIBILITY
made pursuant to and for the purposes of art. 20 of Legislative Decree no. 39/2013**

I, the undersigned Ubirajara VAN KOLCK, with regard to the managerial position⁵ afforded to me by Fondazione

Bruno Kessler on November 21st, 2023, seconded from CNRS from March 1st 2024 to February 28th 2027;

Pursuant to Legislative Decree no. 39 of April 8, 2013;

Pursuant to the DPR n. 445/2000;

Aware that anyone who makes false declarations is punished pursuant to the criminal code and

- 1) that the *"Provisions on the impossibility to appoint and incompatibility of offices in public administrations and private entities under public control are applicable to Fondazione Bruno Kessler, pursuant to article 1, paragraphs 49 and 50, of Law no. 190»* set out in Legislative Decree no. 39/2013;
- 2) **that appointment deeds in violation of the provisions of Legislative Decree no. 39/2013 and the related contracts are void;**
- 3) that this declaration will be published on the website of the entity that has appointed me for the position;
- 4) that this declaration is a condition for the effectiveness of the position;
- 5) that a false declaration entails the impossibility to appoint for any position pursuant to Legislative Decree no. 39/2013 for a period of 5 years;
- 6) that the Head of Corruption Prevention and Transparency has the task of ensuring that the provisions of Legislative Decree no. 39/2013 be respected;
- 7) that the Head of Corruption Prevention and Transparency is required to report cases of possible violation of Legislative Decree no. 39/2013 to the National Anti-Corruption Authority, to the Competition and Market Authority and to the Court of Auditors;

HEREBY DECLARE

- that, with reference to myself, there are no reasons **for impossibility to appoint** pursuant to Legislative Decree no. 39/2013 (see note A);
- that, with reference to myself, there are **no** reasons for **incompatibility** pursuant to Legislative Decree no. 39/2013 (see note B), or, if they exist, that I undertake to terminate them within 15 days from the date of this letter, and that, undertake to submit a similar declaration on a yearly basis;
- that I undertake to promptly report to the Head of FBK Corruption Prevention and Transparency any information regarding reasons for incompatibility that may occur during the performance of the term of my position.
